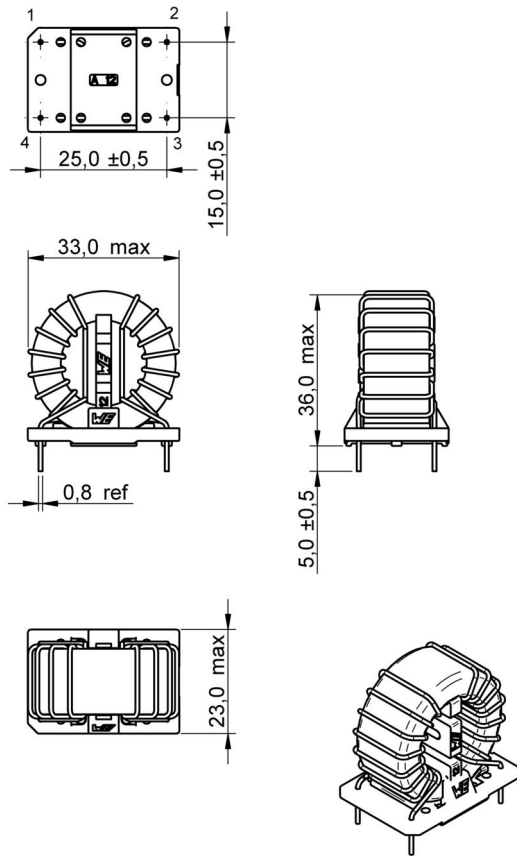
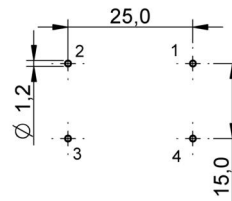

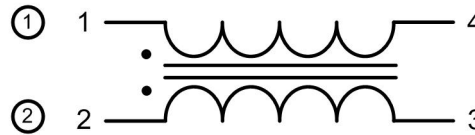

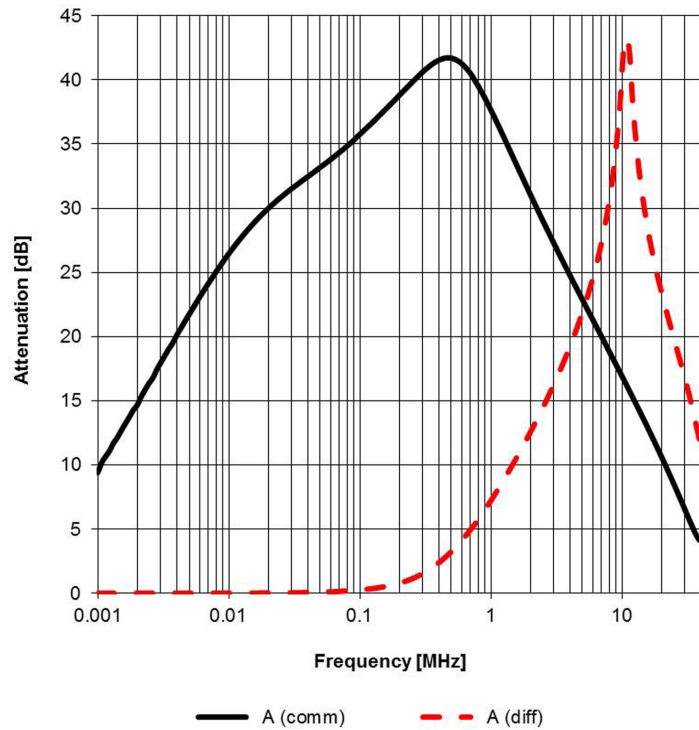



Product specific:
