

After the potting material is cured, the core, wire and termination of the product have to be checked if any reduced electrical or mechanical functions or destructions have occurred.

Cleaning agents that are used to clean the customer application might damage or change the characteristics of the component, body, pins or termination.

- •Wave soldering is not applicable. Reflow soldering is recommended.

- •Violation of the technical product specifications such as exceeding the nominal rated current will void the warranty.
